DAY 1 SATURDAY, JUNE 3

FLIGHT TO ROME

Today we will transfer to the airport for our overnight flight to **Rome, Italy**.

DAY 2 SUNDAY, JUNE 4

ROME, ITALY

(Dinner)

Welcome to **Rome**, a city packed with ancient Roman landmarks and more modern highlights. We'll be met at the airport by our motorcoach and local guide and embark on a **panoramic city tour** as we make our way to our hotel in the heart of Rome. The remainder of the day is at your leisure to explore this magnificent city! Consider making the short walk to admire the Spanish Steps, the widest stairs in Europe, and then head to the Trevi Fountain to toss in a coin backwards over your left shoulder to wish for your return to Rome. More than \$3,000 is thrown in the fountain every day, and the money goes to a local charity that supports the homeless. After a full day, we will freshen up for a delightful dinner as a group.

DAY 3 MONDAY, JUNE 5

ROME, ITALY

(Breakfast, Dinner)

The morning is yours to continue exploring Rome. The Pantheon is always popular, as is the beautiful Baroque Piazza Navona. The piazza has it all: three glorious fountains, Bernini sculptures, a lovely outdoor café scene, and the magnificent Sant'Agnes in Agone church. Shift your focus to antiquity and explore the ruins of one of the greatest empires of all time as you venture to the Colosseum, arguably the world's most famous arena of entertainment, and the Arch of Constantine, the largest and triumphal arch in Rome. There's also Palatine Hill, the location of the imperial palace complex; the Imperial Forum, famously built by Julius Caesar; and Trajan's Column, which reads like a scroll descending from the sky and depicts the victories of the emperor who commissioned it. Another option is the country within a country built to enclose a single complex – the Vatican. The areas open to the public include St. Peter's Basilica, St. Peter's Square, and the Vatican Museums housing over three hundred galleries filled with art representing all the greatest expressions of genius, from Etruscan, Egyptian, Greek, and Roman to Renaissance and Baroque masterpieces. The contents of the collection are unparalleled, but the real draw are the rooms themselves. With interiors by greats like Raphael and the ceiling of the Sistine Chapel by Michelangelo, no better examples of Italian art exist elsewhere in the world. This afternoon we will transfer to the port to board the **Norwegian Breakaway**. We'll spend our evening discovering all the *Breakaway* has to offer as we set sail on our exciting cruise through the Greek Isles.

DAY 4 TUESDAY, JUNE 6

AT SEA

(Breakfast, Lunch, Dinner)

What a great day to enjoy the amenities aboard the ship! Taste your way through some of the nearly two dozen bars, lounges, and restaurants. Savor a classic martini at Shaker's Cocktail Bar; enjoy a drink in the Skyy Vodka Ice Bar where the bar, seating, and glasses are made entirely of ice; enjoy entertaining Japanese cuisine at Teppanyaki; or dine on the freshest seafood at Ocean Blue. DAY 5 WEDNESDAY, JUNE 7

SANTORINI, GREECE

(Breakfast, Lunch, Dinner)

Our days in port are at your leisure. Whitewashed villages clinging to the sides of the sea cliffs with their blue-domed churches have made the volcanic island of **Santorini** one of the most widely photographed places in the world. The island's charm and subtle mystery have even made it a target of speculation as the location of the lost city of Atlantis. While in port, optional excursions include exploring the fascinating excavations of Akrotiri; joining in a lively Greek celebration with food, wine, and dance; or visiting a well-known winery and discovering the many charms of the rooftop village of Oia.

Note: Excursions can vary from sailing to sailing. You will receive a shore excursion book specific to this sailing after registration.

DAY 6 THURSDAY, JUNE 8

MYKONOS, GREECE

(Breakfast, Lunch, Dinner)

Mykonos is the most popular island in the Cyclades, boasting more whitewashed houses and famous blue domes. The white-sand beaches are some of the most stunning you will ever see, and the gorgeous windmills are a quintessential highlight of the island's landscape. Mykonos offers easy access to the ancient island of Delos, the mythical birthplace of Artemis and Apollo. This archaeological site is filled with ruins and stunning relics such as the Avenue of the Lions. Other optional activities include a walking tour through Mykonos' charming, narrow streets to uncover both the lifestyle and history of the island. The deliberately confusing layout of the town was designed to fool attacking pirates and makes for an entertaining adventure today!

DAY 7 FRIDAY, JUNE 9

CORFU, GREECE

(Breakfast, Lunch, Dinner)

One of the lushest of the Greek Isles, **Corfu** is rimmed in dramatic blue waters and topped with tranquil hillside villages. The picturesque island has long cast a spell over visitors. Even the gods weren't immune, as Poseidon is said to have chosen Corfu for his honeymoon! A collection of quaint cafés in the town of Corfu feels very continental, but the island's secluded coves and sandy beaches could only be found in the Greek Isles. There's a long history of art and culture to explore during your time on the island. Embark on a catamaran cruise to take in the stunning Corfu skyline and swim in the crystal-clear waters teeming with marine life. Or wander along the cobblestone streets of Old Town Corfu and marvel at the stunning architecture of beautiful mansions, Byzantine churches, the old fortress, palaces, and more!

DAY 8 SATURDAY, JUNE 10

VALLETTA, MALTA

(Breakfast, Lunch, Dinner)

Malta's colorful history dates back to the dawn of civilization. This small archipelago off the southern coast of Sicily boasts some of the clearest waters in the world and architectural wonders that are thousands of years old. **Valletta** is Malta's capital city, and it prides itself on its magnificent Baroque palaces, piazzas, gardens, and churches. Optional excursions include a walking tour offering an inside look at the state rooms of the Magisterial Palace, a visit to St. John's Co-Cathedral to admire a Caravaggio masterpiece, and a journey to the silent city of Mdina. For those interested in Malta's prehistoric past, there's an exciting excursion to the Temples of Tarxien and Hagar Qim and the caves of Ghar Dalam! Fine wine, talented artisans, and colorful Maltese boats also await on this stunning island country.

DAY 9 SUNDAY, JUNE 11

MESSINA (SICILY), ITALY

(Breakfast, Lunch, Dinner)

The third largest city on the island of Sicily, **Messina** welcomes visitors with its lovely harbor; wonderful food; and extraordinary architecture, much of which miraculously survived a terrible earthquake and tidal wave in 1908. Sicily is unlike anything you will find elsewhere in Italy, with a magic and mystery to enthrall those who visit. Stroll through Messina's historic piazzas admiring magnificent fountains and cathedrals, savor a cannoli, or sip Marsala wine at a sidewalk café. Europe's largest volcano is a unique experience, and there's even a *Godfather* tour that will introduce you to locations used during the filming of the movies. You may also want to consider an excursion to enchanting Taormina to revel in the village's medieval character and charm.

DAY 10 MONDAY, JUNE 12

NAPLES, ITALY

(Breakfast, Lunch, Dinner)

Naples is a city rich in history and located on Italy's stunning Amalfi Coast. A tour around Naples' grand piazzas, cathedrals, and castles in the old center will take you back centuries. The flavors of Italy are bursting here, with plenty of opportunities to sample olive oil, mozzarella, pizza, and wine. Join a bike tour to discover hidden corners, artistic treasures, and the turbulent history of Naples. This Italian city is wonderful to explore on its own, but it also offers easy access to wonderful destinations such as Pompeii, Capri, and the entire Amalfi Coast. Consider an excursion to explore the Pompeii excavations or the ruins of Herculaneum. Or head to Sorrento to experience this cliff-top setting, learn about the art of intarsia, and sip limoncello.

DAY 11 TUESDAY, JUNE 13

FLORENCE/PISA (LIVORNO), ITALY

(Breakfast, Lunch, Dinner)

Welcome to **Livorno**, the gateway to Florence and Pisa considered culturally influential Tuscan cities resplendent in art and history. Venture to Florence to uncover a treasure trove of art and architecture including Michelangelo's *David*, the beautiful Basilica of Santa Croce, the Ponte Vecchio, and the Duomo. The main attractions in Florence are all centrally located, so a walking tour of the city will introduce you to much of what the city has to offer! Other optional excursions include an opportunity to climb the steps of the Leaning Tower of Pisa, a wine tasting in the Tuscan countryside, and a Jeep tour of the marble quarries from which Carrara marble hails. The Cinque Terre is also well worth the journey from Livorno. These five fishing villages along the Italian coast have been designated an UNESCO World Heritage Site and can only be reached by boat, rail, or trail!

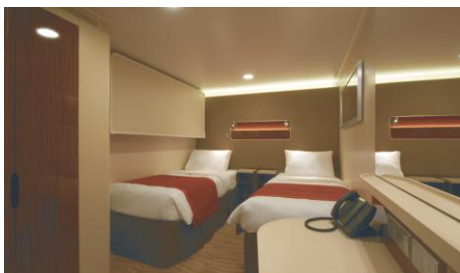
